Andrew Mankin – Head Brewer and Co-owner of Barrington Brewery & Restaurant AND Board Member – Town of Great Barrington Conservation Commission

He stared his career in brewing in 1988 with an apprenticeship at the Vaux Brewery in Sunderland, England.
