## David "Dave" Moresi - Principal Moresi & Associates, Co-owner of Grazie Restaurant

A native of North Adams, David returned to the Berkshires after graduating from Union College in 1997, and embarked on an entrepreneurial lifestyle. In 2000 he established the firm of Moresi & Associates, a diverse real estate management, investment and development company based in his hometown, where he lives with his wife and two daughters.

From its humble beginnings, Moresi & Associates now has 28 employees in its core real estate development business. They are committed to developing and supporting small and independent business and housing ventures in North Adams.

David bought the entire Mulcare Block in 2014 and began extensive renovations later that year. The Mulcare Block now includes the Mohawk Tavern, Grazie restaurant and several residential apartments upstairs.

David purchased the former Excelsior Mill in 2017 and set out with a five-year redevelopment plan. In less than a year, Moresi & Associates had signed 22 leases with businesses that have committed to 80 percent of the 100,000-square-foot historic 19th-century facility, which he has rebranded as the NORAD Mill, in which we sit today.
